The AGM approved the final dividend payment for the fiscal year 2022 as follows:

- Payment date: October 5, 2023.

5. DIVIDEND PAYMENT PLAN FOR THE FISCAL YEAR OF 2023

The AGM approved the cash dividend payment plan for 2023 at a minimum of 50% of the consolidated after-tax profit allocated to the shareholders of the Company. Specifically:

The advance payment of the first dividend for 2023:

■ Payment rate : 15% (equivalent to 1,500 VND/share).

Last registration date : August 4, 2023Payment date : October 5, 2023

- The Board of Directors will decide the amount and timing of the advance payment for the second dividend for 2023 to be in line with the Company's dividend payment plan.

6. SELECTING INDEPENDENT AUDITOR FOR THE YEAR 2023.

The AGM to grant authorities to the Board to select the independent auditor for Vinamilk in the fiscal year of 2023 from the list of Big 4 in Vietnam:

- KPMG Limited Liability Company (KPMG).
- PwC Limited Liability Company (Vietnam) (PwC).
- Ernst & Young Vietnam Limited Liability Company (E&Y).
- Deloitte Vietnam Limited Liability Company.

7. THE TOTAL DIRECTORS' FEES AND OTHER BENEFITS FOR 2023

The Annual General Meeting approved a total remuneration and benefits for the Board of Directors in 2023 of VND 25 billion (with a structure of 11 members).

The remuneration and benefits for the Board of Directors will be calculated and paid accordingly to the actual number of members.

In addition, the Annual General Meeting also approved other benefits for the Board of Directors, including management liability insurance, accident and health insurance, and

annual health check-up according to the Company's general policy. This program will be applied until the Annual General Meeting makes a different decision.

8. AMENDING AND SUPPLEMENTING THE COMPANY'S BUSINESS LINES

The Annual General Meeting approved the amendment and supplementation of the Company's business lines and approved the list of business lines after being amended and supplemented. Details are presented in Appendix 1 attached to this Resolution.

The Annual General Meeting assigned the General Director (who is the legal representative of the Company) to carry out and/or direct the necessary procedures according to legal regulations and/or the guidance of competent state agencies to complete the amendment and supplementation of the Company's business lines.

9. AMENDING THE COMPANY'S CHARTER

The Annual General Meeting approved the amendment of the Charter and the adoption of the new Charter (which updates the amended content, including the amendment and supplementation of business lines as mentioned in Item 8 above) (details are discussed in the documents of the Annual General Meeting in 2023).

Accordingly, the new Charter of the Company will take effect from April 25, 2023, replacing the Charter approved by the Annual General Meeting in 2022.

Article 2: Implementation provisions

- 1. This Resolution shall take effect from the date of signing.
- 2. Shareholders, the Board of Directors, the General Director, and related persons are responsible for implementing this Resolution.
